### Generic

The issues facing District A for residents and businesses are Crime and Infrastructure

## **Criminal Justice**

- To lower gun and violent crime in our city we have to offer more opportunities for individuals to engage in activities and jobs. We will not be able to police or incarcerate our way out of this problem. However, if we use diversion and rehabilitation programs to our advantage, we can show criminals and potential criminals there is a better way to live life. For those that are unable or unwilling to change, restructure the incarceration program to make it a place where they would not want to return to.
- 2. Use the diversion and rehabilitation programs that are available. Through the court system and Bridge House (other programs may exist) we can provide alternate opportunities for individuals that may engage or have engaged in criminal activity. There are programs that can partner with the community colleges or these community schools to help offenders get GEDs and help them learn trades that can be turned into profitable jobs.
- 3. I agree that we should not further burden the indigent population. I also agree that individuals should have to pay for the crimes that they commit. I would like to see a step program implemented in regards to the policy on bail for city offenses. Instead of letting repeat offenders go free, set a range for the offense and the number of times. If they cannot stop committing offenses, then they have to pay or they can work off the amount by doing community service. That community service can include speaking to the youth, picking up trash on the streets, or helping to clean the catch basins.
- 4. The primary focus of the NOPD is and should always be proactive and reactive responses to crime. It is not their job to regulate immigration. If there is no crime being committed, then NOPD should not be used to round up individuals to enforce immigration laws.

Housing, land-use, zoning, preservation, community development and economic opportunity/development, etc

- 1. It is happening because we began to trade culture for gentrification. Instead of creating an allinclusive environment, we approached rebuilding as a separate and unequal task.
- 2. We have to first decide that everyone deserves a right to live in any neighborhood they choose. We can set a tier program that includes all incomes and generations. Regulations on how much housing should cost in regards to the minimum salary of the area.
- 3. Short term rentals should have a mandatory stay of 3 nights or more...
- 4. Use the process that is established. Historic properties house the culture of our city and should be protected instead of demolished. If there is a threat to human safety, then the process for removal can begin. If there is not, repair should take place. Protect the old and respect the new.
